TREASURY ANNOUNCES NEW MARKETS TAX CREDIT ALLOCATION AWARDS

On June 5, 2014, the United States
Department of Treasury ("Treasury")
announced the awardees of New Markets Tax
Credits ("NMTC") for the 2013 NMTC
round. The Treasury awarded a total \$3.5
billion of NMTC to eighty-seven community
development entities ("CDEs") this round.

Brief Summary of the NMTC Program

The NMTC program is a tax credit program which promotes investment in businesses and public facilities located in low income communities. In exchange for a qualified equity investment in a CDE, an investor becomes eligible to receive tax credits from the federal government. The CDE then provides a loan or an equity investment to a qualified active low income community business ("QALICB") that is located in a qualified low income census tract or that provides services or employment opportunities to "targeted populations" comprised of low income individuals.

Some examples of projects financed with the assistance of NMTCs include community centers, charter schools, medical facilities, child care facilities, historic live theater venues, supermarkets, business incubator facilities, shopping centers, office buildings for public agency use, clean technology research facilities, manufacturing plants, mixed use projects, hotels, public libraries, office parks serving nonprofit organizations, and affordable housing.
